2022-2024

Tentative Timeline

- **December 2021 May 2022** Drive a more diverse and inclusive NAP 5 co-creation process in partnership with a well supported Multi-Stakeholder Forum.
- **June 2022 August 2022** Finalize the NAP 5 document and run through the clearance process.
- **September 2022** Publish NAP 5
- **December 2022** January 2023: The OGP IRM will compile a Design Report for our NAP 5 (These dates aren't fixed, just 3-4 months after our plan is published)
- **September 1, 2022 August 31, 2024**: NAP 5 commitment implementation updates are published at least once every 6 months
- **August 31, 2024**: Final date for completing NAP 5 commitments
- **November 30, 2024**: We publish our End of Term Self-Assessment for NAP 5
- **November December 2024**: The OGP IRM will compile a Results Report for our NAP 5

Legal Authorities

2010 - America COMPETES Reauthorization Act (P.L. 111-358)

2017 - American Innovation and Competitiveness Act (P.L. 114-329)

In the 116th Congress (2019 - 2020) > 30 bills were introduced to authorize or establish prize competitions at various federal agencies:

- Senate: 32 sponsors or co-sponsors
- US House of Representatives: 44 sponsors or co-sponsors
- These prize competitions address issues including energy, climate change, environmental protection, and medical technology



Designing an Improved Process: "OPALS"



- **Ownership**: including strong White House leadership
- Participation: broad, more diverse CS engagement, beyond usual suspects
- **Ambition**: new reforms linked to national priorities
- Looped Feedback: report backs; ongoing joint work
- **Synchronization:** linking local and global

5 Promising Policy Areas for 5th NAP



- 1. Core democracy and good government reforms
- 2. Disclosures and declassification
- 3. Regulating tech and generating usable data
- 4. Criminal justice and access to justice
- 5. Further implement/fulfil existing commitments (ex: NDAA; HR treaties)

The Opportunity Project (TOP) is an innovation program that brings together technologists, government, and communities to co-create digital tools with open data.

Technology development sprints

- Workshops and roundtables
 - → Prize competitions
 - Data curation

What Happened Since?

In 6 years and 13 sprint cycles...

150+ digital products

Tackling challenges like ocean plastic pollution, workforce development, entrepreneurship, COVID-19, disaster response, rural development, and more.

25+ federal agencies engaged

6 Demo Days (1 Demo Week) **\$100,000** in prizes awarded
