Pursuant to OSHA regulation 29 CFR §1903.14a, the General Services Administration, Region 6 submitted a Petition for Modification of Abatement Date. We received an initial modification for the following three citations for February 15, 2017. However, due to unforeseen circumstances, we are requesting a second modification for abatement date of May 31, 2017. We respectfully submit the following information for your consideration:

Notice 1 Item 1a: Serious - 29 CFR 1910.219(b)(1) Guarding...Elevator Equipment

Additional Time Needed To Abate: We respectfully request the abatement date be moved to May 31, 2017. A project to install permanent guards on all the unguarded elevator equipment (including Building 104-B16, 105-B16, 105-B4, and 105F-M36) was funded on July 18, 2016. The equipment guarding project was awarded and scheduled to start in August, 2016. However, in performing our due diligence, we suffered several delays in negotiating an acceptable site specific safety plan with the elevator contractor so their employees are properly protected when working in the areas contaminated with the environmental contaminants that are present. We finally received an acceptable plan on February 2, 2017 and issued the notice to proceed. The project is scheduled to start in the next two weeks barring any more difficulties.
