FY2014 Summary of Fleet Data Set

Office of Asset and Transportation Management

History and Overview of Data Set:

Federal agency motor vehicle fleet data is collected and released as a result of a 1949 Bureau of the Budget Circular delegating responsibility for the collecting and publishing of motor vehicle fleet data to GSA. Prior to FY 2010, GSA produced an annual Federal Fleet Report in printed hard-copy format and mailed copies to interested parties and stakeholders including certain Congressional committees. Currently, the Federal Fleet Open Data Set is only produced electronically and published as a set of data tables made available on the GSA website and on data.gov.

Types of Data Collected:

The Federal Fleet Open Data Set is compiled from data Federal agencies submit to the Federal Automotive Statistical Tool (FAST) during the annual data call each October-December. FAST is a web-based reporting tool jointly sponsored by GSA's Office of Government-wide Policy (OGP), the Department of Energy's Federal Energy Management Program (DOE FEMP), and the Energy Information Administration (EIA). The data set presents a fiscal year-end summary-level snapshot of Federal agencies' motor vehicle fleet inventory, cost, utilization, and fuel consumption.

Key Statistics:

During FY 2014, Federal agencies:

- had an inventory of 633,851 vehicles;
- Traveled 4.6 billion miles;
- Consumed 380 million gasoline-gallon equivalents of fuel; and
- Incurred \$4.4 billion in fleet costs.

Significant Increases from FY 2013 to FY 2014:

There were no significant increases in Federal agency reported motor vehicle inventory, cost, utilization, or fuel consumption.

Significant Decreases from FY 2013 to FY 2014:

Inventory

Federal motor vehicle fleet inventory has decreased in all motor vehicle categories in FY 2014. The FY 2014 reduction of 1,897 vehicles (0.3 percent of total inventory) contributes to an overall motor vehicle fleet reduction that has occurred for the past 4 years. The total motor vehicle inventory at the end of FY 2014 was 633,851.

Cost

Total reported motor vehicle fleet cost was nearly flat in FY 2014, increasing by 0.1 percent (less than \$5.9 million). The total Federal motor vehicle fleet's cost for FY 2014 was \$4.45 billion.

Utilization

Utilization is expressed here in terms of miles traveled. Miles traveled declined by nearly 225 million miles (4.7 percent) in FY 2014. Miles traveled dropped in FY 2014 for both domestic and foreign motor vehicle fleets. In FY 2014, Federal agency motor vehicle fleets travelled 4.595 billion miles.

Fuel Consumption

The total fuel consumption reported by Federal motor vehicle fleets declined 0.8 percent (3,039,810 gallon equivalents) in FY 2014.
